### I. COMPANY PROFILE

National Aluminium Company Limited (NALCO) was incorporated under the Companies Act, 1956 with the objective to be a premier Aluminium producing company of global repute. NALCO is engaged in mining of Bauxite and manufacture of Alumina and Aluminum. The product portfolio includes, Smelter grade Alumina, Aluminium ingots, rolled products, wire rods and billets. NALCO is a consistently profit making, Schedule 'A' Navratna CPSE with the administrative jurisdiction of Ministry of Mines.

The company employed 5339 regular employees (Executives: 1592, Non-Executives: 3747) as on 31.3.2022.

The authorized and paid up capital of the Company was Rs. 3000 Crores and Rs. 918.32 Crores respectively as on 31.03.2022.

Its Registered and Corporate office is at Bhubaneswar, Odisha.

The shareholding of the Government of India in the company is 51.28% as on 31.03 2022.

### II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Production) is a member of the Board of Directors and reports to the Chairman and Managing Director. He is responsible for all production activities of the Company at various units viz: Mining, Alumina Refining, Power Plant and Aluminium Smelter. He is also responsible for efficient operation and maintenance of plant, besides coordination with connected agencies and

introduction of new and efficient technology, promoting indigenization under Atma Nirbhar Scheme of the Government.

### 3. QUALIFICATION:

The applicant should be an Engineering Graduate with good academic record from a recognized university/ institution.

Applicants holding MBA/ Post Graduate Diploma in management will have an added advantage.

### 4. EXPERIENCE:

The applicant should have at least five years of cumulative experience/exposure during the last ten years in metallurgical sector at a senior management in an organization of repute. Experience in Mining sector is desirable.

## IV. DURATION OF APPOINTMENT

Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

### 3. For candidates from SPSE/ Private Sector

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.
- 4. In the above cases, no request for relaxation or otherwise would be entertained.
